

Information clause of the processing of personal data

Pursuant to Article 13.1 and 13.2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter as GDPR Regulation), we hereby inform that:

1. Joint controllers of personal data are:
 - University of Łódź having its seat in Łódź, ul. Narutowicza 68, 90-136 Łódź, Poland
 - University of Warsaw having its seat in Warsaw, ul. Krakowskie Przedmieście 26/28, 00-927 Warszawa, Poland
2. Joint controllers have appointed Data Protection Officers, who may be contacted via email:
 - UŁ – via email: iod@uni.lodz.pl;
 - UW – via email: iod@adm.uw.edu.pl
3. Personal data will be processed only for the purposes of:
 - registration of active and passive participation in international academic conference;
 - handling of the registered participants of academic conference, including communication with participants and settlement of participation fee;
 - organising the conference taking place on 25-27 June 2023.

Personal data will be processed based on:

- Article 6.1 e) of the GDPR Regulation i.e. based on the performance of a task carried out in public interest, which is laid down by the Act of 20 July 2018 The Law on Higher Education and Science and is related to the mission of higher education system and science in the field of education, academic activity, citizenship creation, as well as participation in the social development and in building the innovation-based economy;
- under the Article 6.1 b) of the GDPR Regulation based on the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract;
- under the Article 6.1 c) of the GDPR Regulation i.e. based on the performance of legal obligations of the joint controllers;
- under the Article 6.1 a) of the GDPR Regulation i.e. based on the data subject's consent to the processing (in case of consent to the processing of the data subject's image).

4. The provision of personal data is voluntary, but necessary to participate in the Conference.
5. Your personal data will not be shared with other entities, except for the entities entitled to by the law and entities with whom joint controllers concluded agreements.
7. Your personal data will not be subjected to profiling, neither will any automatised decisions be taken based on those data.
8. In case of:
 - participation registration, data will be processed throughout the time necessary for organisation of the conference, communication with You related to the organisation of the event and for the time of necessary storage of financial and accounting documentation;
 - data of active conference participants (included i.a. in the academic articles) will be processed perpetually;
 - Your data processed based on the consent, data will be processed until the moment of consent withdrawal.
9. The data subject has the right to request access to his/her personal data, their rectification, to objection against personal data processing and limitation of their processing. In case of personal data processed based on the consent, You are entitled to the consent withdrawal at any time.



10. You have a right to lodge a complaint to the supervisory authority in Poland i.e. the President of the Personal Data Protection Office, if you consider that processing of Your personal data has infringed GDPR Regulation.
